Doctors told me I did not have food poisoning but rather a stomach virus. Over the next year, the number of foods I could eat was decreasing and I continued to get more and more ill. Finally, doctors diagnosed me with colitis in 2006 and put me on Asacol - a non-steroidal anti-inflammatory. These pills were not working so doctors wanted to put me on stronger medications and told me I would be on these medications for life.</p> <p>Not interested in taking medications where the side effects were the same as the issues I was trying to resolve, I began to seek help from naturopaths. I had some successes but it was definitely a two-step forward, one step back process. The number of foods I could eat kept on decreasing, even with the help from the naturopath, to the point where no matter what food I ate I felt sick. I had lost 30 lbs throughout all of this and had very little energy - getting out of bed was a challenge most days.</p> <p>Blood tests that I had done through a naturopath had revealed a significant egg allergy, and also allergies to dairy, almonds and pineapple. As the foods I could eat continued to decrease, I started to search for a way to treat my egg allergy and this is how I found NAET.</p> <p>When I first started NAET, muscle testing had revealed that I was actually allergic to most items under the basic 15 (such as vitamin C, B complex, sugar, salt etc), and many more items beyond that. It also confirmed that I had contracted a bacteria and a parasite when I had the food poisoning in 2005. <p>Cysts and Granite Allergy</p>	<p>I am a 53 year old woman who had been going to MC for NAET treatments every 2 weeks for about 5 months. All my initial issues had been treated successfully and I decided to take a break for the winter months. At the beginning of December, my period started but wouldn't go away. I had never missed a period, although I understand that is unusual for my age. I figured that it was the onset of menopause; it was not heavy, just a nuisance. After 6 weeks, my period became extremely heavy. I went to see my medical doctor and he gave me 10 birth control pills to stop my period, and made an appointment for an ultrasound and an appointment with a gynecologist 2 months later. On the pill, my period stopped only a couple days, then came back with a vengeance. The ultrasound showed multiple cysts on my ovaries and uterus, which I had never had. I returned to my doctor and he gave me more of the same pills while I waited to see the gynecologist. I went back to MC in February and we discussed my new issues. She had me describe my kitchen and determined that I was allergic to my Silestone countertop. Silestone is granite that has been ground up and put back together with epoxy to have a more uniform look. We discussed the fact that when I stand in the kitchen, my countertop is level with my uterus. I also have a breakfast counter, and when I sit, the counter is level with my uterus.</p> <p>I went to a kitchen store and got a piece of the exact Silestone so I could be treated. Since I was so allergic, I had to spend a night in a hotel, to be far away from my kitchen. I finally went to see the gynecologist. He didn't examine me, just gave me 2 weeks worth of birth control pills, and told me to come back for a biopsy in 5 weeks. After the pills, my period came back with a vengeance yet again. It had finally stopped on its own and then I went for the biopsy. I waited 2 weeks for the diagnosis, and everything is fine.</p> <p>I am now having regular periods again. I would rather be done with them, however, after all the tests and medicine, I know</p>

	<p>that MC was the only one who asked why, and the only one to answer the question. If a 4 month period is normal for the beginning of menopause, then I would be done. I am not finished, I believe that my allergy has been cured, and I am back to regular periods. <p>Hormone Balancing and Effects</p>	<p>When I was in my late 30s, I didn’t recognize that perimenopause symptoms were occurring, mostly because the only symptom I was faintly aware of was hot flashes, which I didn’t suffer. It was all so gradual when it started, yet the whole process, overall, was fast. My medical doctor didn’t recommend hormone replacement, nor advise me of available options. I don’t know that she recognized I was peri-menopausal. By the time I was 41 (I am now 52), menopause was completed, and with it, my libido crashed, my energy levels gradually dissipated, concentration was scattered and my genitalia became atrophied, resulting in painful sexual intimacy. To top it off, I wasn’t even remotely interested in anything sexual; it was as though I had “flat-lined” or had the non-feelings of being a neuter.</p> <p>Fast-forward to 2010 and NAET. <p>Horse conjunctivitis</p>	<p>Five of our horses (out of twelve) came down with eye problems because of flies and conjunctival infestation by *Habronema muscae* (nematode) larvae. We tried treating holistically, but the treatment was taking too long. The following drugs proved helpful: oral liquid ivermectin and eye antibiotic/steroid ointment. Four of the horses cleared up, but one gelding did not resolve. He worsened, developing a nasty, weeping granuloma at, and distal to the medial canthus of the left eye, including the punctum, probably because of inflammation of the nasolacrimal duct. The nematodes literally ate their way out onto his cheek and were invading surrounding tissues. The lesion was 6 cm in diameter, raised, weeping and granulomatous in nature when it was brought to our attention by the handler. This was one of the worst 'Summer Sores' I've seen in a long time, and it developed quite rapidly. Summer sores are caused by * Habronema muscae * larvae which are supposedly deposited in an open wound by flies. The flies pick up the larvae on their feet while feeding at manure piles. When deposited into open wounds or onto intact conjunctival membranes, the larvae cease development, but seem to live forever, burrowing in the tissue. Cold weather stops larval activity so that lesions heal up in the winter, but they reappear as soon as warm weather returns.</p> <p>I tested for allergy (Using Nambudripad's Allergy Elimination Technique) and found that the gelding was allergic to the nematode larvae! We got a sample of manure (where the larvae hang out) and used that as an allergen. We cleared the allergy in the usual way. Fifteen minutes later we wormed the horse with liquid oral ivermectin and applied an ivermectin/nolvasan ointment mixture to the facial granulomas. The very next day brought improvement. The granuloma was diminished in size and was scabbing over. There is now a peripheral area of epithelialization and clear evidence of healing. Repeat NAET® testing shows the patient is no longer allergic to the Habronema larvae. We are using nutritional supplements in an attempt to reduce the size of scars.</p> <p>Aside: One horse with a "normal" case of conjunctival Habronemiasis was treated by the university but was not responsive to the ivermectin therapy. NAET® Testing revealed that the adult gelding was allergic to ivermectin. Clearing the allergy to ivermectin allowed resolution of the conjunctival problem.</p> <p>Of course, this is only a single case. However, next time you find a non-responsive case of summer sores (or other granulomatous lesion), check with NAET® to rule out allergy to a parasite or other pathogen. (We have also found dogs allergic to the bacteria causing their dermatitis, but that's another story.)</p>

She had delivered puppies only six days before, and her breathing had become so rapid and loud as she nursed, that I was terrified we would lose her. After a full examination, blood work-up and X-Rays, I was told that she had chronic bronchitis, but worse still, a serious uterine infection. They wanted to keep her, start IV's and prepare for surgery, although I was warned that she “might not make it.” Her uterus was very large, and the breathing problem made the anesthesia situation difficult. Even if she survived the surgery, they doubted that she would be able to care for or nurse the puppies.</p> <p>Although the doctor warned me that Liebshen might die, I could not leave her (and the four puppies) there. I felt that the psychological trauma would be too much for her to bear. So she was started on oral antibiotics and bronchial medications and we went home. The morning was stressful. Although her breathing improved slightly, she was strangely restless, and avoided nursing the puppies.</p> <p>In the meantime, Dr. Devi Nambudripad had begun the first day of an NAET® Self-Help Program at SKY Farm, which I was scheduled to attend. As I heard later, Dr. Devi was talking to the group about her experiences in treating both people and animals with NAET®. Candace Smith, who was a student in the course, explained to Dr. Nambudripad that I had not come because of Liebshen's illness. I went home in a daze.</p> <p>Liebshen completed the antibiotics without a problem. I never had to give her any bronchial medication. She is doing great. The puppies are doing great.</p> <p>Miracle is not a word to be used lightly. But it is the only word that is appropriate for Liebshen’s story. Thank you Dr. Devi. She tried to tell them that she had never had arthritis before and that she felt there was a connection to the CO poisoning but they dismissed this and told her it was unrelated. This made her furious because she did not have any sign of arthritis until this incident and doctors refused to believe her. They tried to convince her that she must be diabetic. She's not. Over a couple of weeks it lasted a total of about 22 hours testing. Nothing was found. On doctor's orders, I obtained a medic alert bracelet and have felt uneasy for the past two years. I carried an Epi pen.</p> <p>I began NAET treatments with my NAET practitioner, MC and finished the basic 15 and all their combinations including the related emotions. After that I asked if we could try to determine what my severe allergy was. My NAET practitioner agreed. We used muscle-testing beginning with the question... "Is the substance in Kit 1, Kit 2", etc. The substance was in Kit 19. My NAET practitioner muscle tested the substances in Kit 19. She looked puzzled. I asked her what the issue was and she said "I don't know how you would come in contact with this substance". The substance was surgical steel. My husband does bonsai and I had purchased a surgical steel scalpel for his hobby. It was that day that I went to the emergency ward of the hospital. MC determined that my allergy was emotional. My only other contact with surgical steel was in a surgery after I had a miscarriage. My practitioner held the vial and muscle tested if this was the substance I was anaphylactic to. We then re-tested surgical steel and found there was no more allergy. I no longer had anaphylactic reactions to this vial. I had been wearing a medic alert bracelet and took it off. I no longer needed it. I stopped carrying an Epi pen. What I didn't tell my practitioner till a later date was that after the testing, I had a biopsy and I had no reaction at all. <p>Vulvodynia and Fibromyalgia</p>	<p>A 51-year old female presented with a chief complaint of vulvodynia and fibromyalgia. Her vulvar pain was so intense that it was difficult to sit or walk. During the history taking she fidgeted and changed positions almost constantly and I could tell she</p>

	<p>was in a great deal of pain. She had been unable to have intimate relationship with her husband for over a year and this was putting a strain in her marriage. The constant pain was making it difficult for her to function in any aspect of her life.</p> <p>On my case history form there is a question that asks, "How long has it been since you really felt good?" She stated: "Years - I had female problems all my life, then had hysterectomy, then fibromyalgia started 6 weeks later. That continued for the past three years - every joint in my body was burning and aching and often I had intense stabbing pains, then I developed vulvodynia for the last year".</p> <p>She was thoroughly evaluated by specialists at the University of Michigan and by many other doctors too. No one could give her any explanation for her pain or any relief. She was given pain medication and antidepressants. An interesting thing about this case is that she told me she had already done some NAET treatments with another practitioner. She said she had cleared all the basics. When I tested her she was clear for the first five including sugar, but she hadn't cleared for the rest. She was allergic to iron, vitamin A, minerals, salt, chlorides, corn, and grains. She insisted she had done these treatments so I explained that evidently these treatments had not held and we need to treat them. Once we did this through grains her symptoms started to improve.</p> <p>We cleared her for many other foods, hormones, DHEA, oxalic acid, and oxalates (which sometimes aggravate vulvodynia) and she is totally free from pain now. She can sit for long periods at a time, she can even have intimate relationship with her husband without any discomfort whatsoever. Her marriage is stronger than ever now.
